“The Pace” is a mini version of a day riding across natural, open countryside. There will be a flagged course of about four miles through beautiful terrain of woods, creeks, and open fields (with a course for both jumping and non-jumping teams). Teams may consist of two to four riders that will ride over a well marked course. You may trot, gallop, or walk. There will be a water station on course. The team closest to the optimum time set by the officials without going faster will be the winner. Awards will be given for 1st thru 3rd place in the Jumping, Non-Jumping, Family, and Best Turned Out/Costume Divisions. Awards will be given out at the picnic.

The start times for Teams will be between 8:00 A.M. – 11:30 A.M. Teams will be sent out at 2 to 3-minute intervals. Leadliners will start at 11:30 A.M. and will be sent out in 1 to 2 Minute intervals. We will make every effort to schedule your start time as requested.
